TALENT MANAGEMENT

This contract ("Contract") is entered into on Date: **June 1, 2026** between Elite Talent Management ("Agent"), represented by Sevag Sagherian, and **Stephen** (Talent").

1. Agency Representation

1.1 The Talent hereby appoints the Agent as their exclusive Talent agent for the purpose of representing the Athlete/Actor in all matters relating to their professional acting career and entertainment venture.

1.2 The Agent agrees to use their best efforts to promote and advance the Talent's career, including but not limited to negotiating contracts, endorsements, appearances, and other opportunities.

2. Term:

2.1 This Contract shall commence on **June 1, 2026** and continue for a period of One Year/365Days, unless terminated earlier as provided herein.

2.2 Either party may terminate this Contract upon 30 days written notice to the other party, provided that such termination shall not affect any rights or obligations accrued prior to termination.

3. Agent's Duties:

3.1 The Agent shall represent the Talent diligently and professionally, acting in the Talent's best interests at all times.

3.2 The Agent shall negotiate contracts, endorsements, appearances, and other opportunities on behalf of the Talent, seeking to secure the most favorable terms possible.

3.3 The Agent shall keep the Talent informed of all material developments and decisions relating to their career and shall consult with the Talent on important matters.

4. Talent's Duties:

4.1 The Talent shall cooperate fully with the Agent and provide them with all necessary information and assistance to enable the Agent to effectively represent the Talent. The Talent must BOOK OUT when they are not available to attend auditions.

4.2 The Talent shall promptly notify the Agent of any offers, opportunities, or developments related to their career.

4.3 The Talent shall adhere to all contractual obligations entered into as a result of the Agent's representation.

5. Compensation:

5.1 In consideration of the Agent's services, the Talent shall pay the Agent a commission equal to commission percentage of 15% from commercials, tv shows, film ventures, 20% from appearances and print/stills work and signings of all gross earnings generated by the Talent during the term of this contract. All Non-union projects that are negotiated or established with the casting director/production/project prior to the Talent's participation on the project by the agent where the agent negotiates or is entitled to a 15%-20% additional agency fee for print and or commercials is the agency's commission on top of the standard 15-20% agency fee that is deducted from the Talent's pay. To clarify further. All Union projects will be subjected to a 15% Agency Commission. All Non-Union Projects will be subjected to 15% Agency commission and potentially an additional 15% Agency Commission arranged by the Agency and Producer/Casting Director on top of the standard 15% commission that does not affect the Athlete/Talent. Print Projects are subjected to a 20% industry standard agency commission.

5.2 The Agent shall be entitled to receive their commission upon the Talent's receipt of payment for any tv/film/commercial contract, endorsement, appearance, or other opportunity negotiated by the Agent. Moreover, the Talent shall sign an "Agent Authorization Form" that redirects all checks and payments to the agent first; Allowing the agent to make their agency deduction of their commission and reissue payment to the Talent. Payments should come C/O Elite Talent Mgmt. and Talent's Name **Stephen**.

5. 2 Any individual participating in an audition, booking, or project opportunity through a talent represented by Elite Talent Management acknowledges and agrees that Elite Talent Management shall act as their agency and/or representative solely for that specific project or engagement. By participating, the individual agrees to be bound by the same terms, conditions, policies, and obligations applicable to talent formally represented by Elite Talent Management, including but not limited to the payment of the standard fifteen percent (15%) agency fee on all gross compensation earned in connection with the project.

6. Continentality:

6.1 Both parties agree to maintain the confidentiality of all information shared during the course of their relationship under this Contract, including but not limited to contract terms, financial information, and strategic plans.

7. Governing Law:

7.1 This Contract shall be governed by and construed in accordance with the laws of Jurisdiction of the Province of Ontario Canada, without regard to its conflict of law principles.

8. Entire Agreement:

8.1 This Contract constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements and understandings, whether written or oral, relating to such subject matter.
